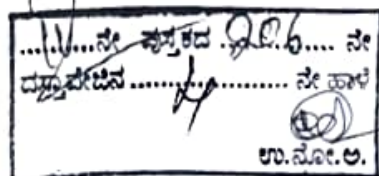

10. TRUST PROPERTY:
- a) The term "Trust Property" shall mean and include the initial corpus donations contributed by the donors-cum-Founder Trustees, further grants, donations, contributions of money, and or property, movable or immovable that may be made by the Doners or by others from time to time and accumulations, profits or gains therefrom in whatever form they may be or varies from time to time.

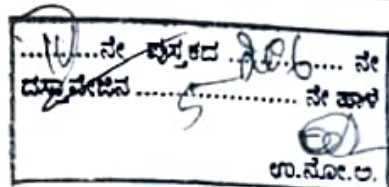

- b) The Trust property shall vest in the Board of Trustees who shall hold, manage and administer the Trust in accordance with the terms and provisions hereof.

11. **TRUSTEES:** The number of Trustees shall not be less than 5 and not more than 10. The (first 5 Founder Trustees shall hold office for a period of 3 years initially, and on their retirement, they are eligible for re-appointment. The vacancies occurring in Trustees, due to resignation, retirement or death or for any other reason may be filled up by co-option of any other member of person as per the direction and majority decision of the remaining Trustees from time to time. The Trustees shall elect from among themselves, the President, Secretary and allocate their duties and power.

12. **POWERS AND DUTIES OF TRUSTEES:** The Trustees shall have the general power to manage the whole affairs of the Trust and in particulars:-

- a) To conduct their own meetings and business to carryout the objects of the Trust.
- b) To appoint sub-committees, to employ and to terminate the staff members, to obtain and secure any movable or immovable property to Trust, to construct any building for the objects of the Trust etc.

- c) To open any current or other accounts with any Bank and arrange for the operation of such account jointly by President and secretary to invest the Trust fund in any immovable property or in Trust securities to fund sell any property of the Trust, to raise funds by receipt of donations, and to incur necessary expenditure or carrying out the objects of the Trust.
- d) The Trustees have the power to consider any application for membership and to decide, to appoint teachers and other workers for the educational institutions and other ventures and to decide their pay, leave etc., etc.
13. ACCOUNTS & ACCOUNTING YEAR: The Accounting year of the Trust shall be financial year i.e., from 1st April to 31st of March; and the Trustees shall cause maintenance of regular and proper accounts in respect of all transactions and dealing and such annual accounts shall be got audited by a qualified chartered Accountant every year.
14. MEETING AND PROCEEDINGS OF THE TRUST:
- a) The Board of Trustees shall meet at least once in 3/6 months with a clear notice of 14 days issued by the secretary of the Trust.
- b) The quorum of holding the meeting shall be follows:

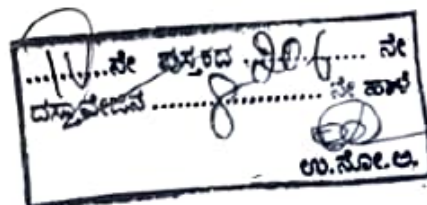

- d) The Trustees shall not be entitled to any remuneration but may be reimbursed out of the Trust funds, all expenses incurred in or about the execution of the work of the Trust.
16. MINUTES BOOKS: A minute book shall be maintained by the secretary under the supervision of the president and kept at the office of the Board of Trustees. A minutes of all the meetings, appointments and entry into the office of every new Trustees and also other proceedings of the Board of Trustees shall be entered and recorded in such minutes books and shall signed by the president of the meetings either at the conclusion of which meeting or at subsequent meeting when they are duly confined.
17. POWERS OF PRESIDENT/SECRETARY: The president or the secretary, shall subject to the supervision direction and control of the Board of Trustees, have the following powers in general:
- To appoint such employees or staff or teachers and to regulate their pay and service conditions from time to time and to terminate their services.
 - To pay the cost, charges and expenses incidental for or in any manner connected with the Trust;
 - To make and give receipts, release or other discharge for money payable to the Trust and for the claims and demands of the Trust;

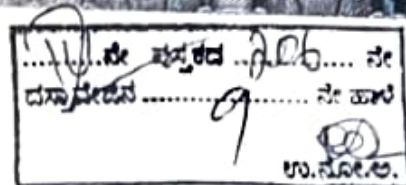

- d) To institute, conduct, defend, compound, any suit or dispute against the persons connected with Trust or the institution.
- e) To open, operate any bank account;
- To enter into all such negotiations and contracts, and execute and do all such acts and deeds, to let out or to take on lease any building to carry out the objects of the Trust, to appoint any person to be attorney, advocate or agent of the Trust to conduct any legal proceedings, before any Government or local authority for the Trust.
- 18) **AMENDMENT CLAUSE:** No amendments to the Trust Deed, Memorandum of Association and rules and regulations, shall be made which may prove to be repugnant to the provisions of Sections 2(15), section 11, 12 and 13 and 80-G of the Income Tax Act, 1961, as amended from time to time. Further no amendment shall be carried out without the prior approval of the commissioner of Income Tax.
- 19) **DISSOLUTION CLAUSE:** In the even of dissolution or winding up of the Trust, the assets remaining as on the date of dissolution shall under no circumstances be distributed among the Trustees/Members of the Board of Trustees, but the same shall be transferred to another charitable trust, whose objects are similar, to those of this Trust and which enjoys recognition under section 80-G of the Income Tax Act, 1961, as amended from time to time.

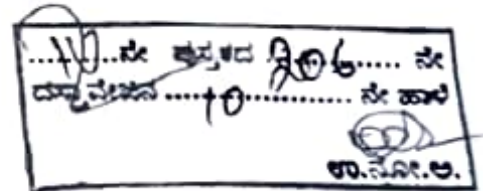
